This course is recommended for you if you have aspirations to move into a role where you will be directly caring for children in an Early Childhood Education and Care Setting. This course is the foundation qualification for all Childcare Professionals. It is an essential stepping stone to a meaningful career for people with a natural affinity and interest in the development and education of young children. This course encompasses child development, the importance of Educator and family partnerships, and develops a sound knowledge of the major curriculum learning areas. It will provide you with the practical experience and theoretical knowledge required in an Early Childhood Education and Care setting.

Entry Requirements

There are no set pre-requisites for this qualification however; you must show:

- A satisfactory level of language and literacy skills, which will be established at the time of enrolment
- A genuine desire to work in the Early Childhood Education and Care profession
- WA students over 18 must hold a current Working with Children Check Card (we will assist you in applying for one of these if you do not currently hold one).
